**REGISTRATION OF HORSE OWNERSHIP FOR THE OLYMPIC GAMES -
CLARIFICATION**

Further to the information provided in the FEI OLYMPIC UPDATE communication of 12 October 2011, we hereby remind you again that Horses entered for the Equestrian Events at the Olympic Games must have been registered with the FEI as property of Owners of the same nationality as the Athlete prior to 31 December 2011. We would like to point out that “Owner” is defined in the FEI General Regulations as “a person or

entity having a property interest in whole or in part of one or more horses” while a Lessee is defined as “a person or entity who receives the use and possession of leased property (e.g. Horse) from a lessor.” Therefore, please be advised that only an Owner of the same nationality as the Horse and not a Lessee can be accepted for this purpose.

Please also note that if a Horse is owned by multiple Owners, the name and relevant nationality of only one Owner is necessary to be registered with the FEI by the aforesaid deadline.
